PROJECT OVERVIEW

Thirteen students currently housed at the juvenile corrections facility have created original poems reflecting their thoughts, experiences, and perspectives. Jeff Public Arts is inviting artists to create original visual artworks inspired by these poems.

For the safety and privacy of the students, all poems will be shared anonymously, and there will be no direct contact between artists and students.

This project centers on empathy, creative connection, and the power of art to amplify voices through creative expression.

ARTIST PARTICIPATION DETAILS

- Artists will be assigned one anonymous student poem as inspiration.
- Each selected artist will create one original visual artwork inspired by the poem.
- Medium is open to 2D visual arts (painting, drawing, mixed media, digital, collage, etc.).
- Final size and format will be coordinated with Jeff Public Arts.
- A print of the final artwork will be provided to the student to keep.

ARTWORK & OWNERSHIP OPTIONS

Artists may choose one of the following options for the original artwork:

- Donate the original artwork to Jeff Public Arts for potential exhibition and programming purposes, or
- Retain the original artwork for their personal collection.

PUBLIC EXHIBITION

Both the original student poems and the completed visual artworks will be presented together as a public exhibition at the NoCo Arts Center, with the potential for the exhibition to also be displayed at the Clark County Courthouse. Other locations are in the works.

The exhibition is tentatively planned for Summer–Fall 2026 and will be on view for a minimum of one month, allowing time for meaningful public and community viewing. Student anonymity will be fully maintained.

STIPEND

While we passionately believe that artists should be paid for their creative works and though we are working on a stipend for participating artists we cannot guaranteed at this time.

ELIGIBILITY

- Open to local and regional visual artists
- Artists of all experience levels are encouraged to apply
- Must be comfortable working from written material and honoring anonymity

- Poems Shared: By May 1st.

- Exhibition (Optional): Fall 2026
